Dear Michael,

As your State Senator, I strive to inform my constituents about important state programs that are available. I am writing to you, a Certified Public Accountant, because of your experience with our state tax programs. In your professional life, you will be influential in helping those who qualify, apply for the Pennsylvania Property Tax and Rent Rebate program.

As you may know, The Property Tax and Rent Rebate program benefits qualifying Pennsylvanian's age 65 and older, widows and widowers' age 50 or older, and people with permanent disabilities age 18 or older with a household income up to \$35,000 and renters under \$15,000, after they divide their social security in half. This year the number of Pennsylvanian citizens eligible for the rebate is expected to be close to 900,000. Despite this, *many Pennsylvanians are not aware that they qualify for this vital program*, which is why I continue to reach out to the professional individuals who *might be able to assist qualified residents*.

If you think any of your customers may be eligible for the PA Property Tax and Rent Rebate Program or should you need applications for the rebate, please contact my office.
